Reservation: A reservation fee of 200,000.00 Baht is required.

Sign Contract: This step involves paying 35% of the total cost. This payment should be made within 30 days after the reservation.

1st Payment: A payment of 15% is due upon the completion of the foundation posts.

2nd Payment: Another 15% payment is required once the concrete structure of the property is finished.

3rd Payment: This stage requires a 15% payment and is due upon the completion of the walls and door frames.

4th Payment: An additional 15% is to be paid when the floors are finished, along with built-in furniture, painting, doors, and windows.

Transfer and Registration: The final stage involves a 5% payment, which is due at the time of transfer and registration of the property.

Each payment is contingent on the completion of specific construction milestones, ensuring progress in the property development. Here are some important remarks regarding the payment terms and conditions:

Reservation Deposit: The reservation deposit is non-refundable. This means that if you decide not to proceed with the purchase, this deposit will not be returned.

Furniture: The prices do not include loose furniture. Any furniture that is not built-in or fixed to the property will need to be purchased separately.

Common Area Fees: These are charged at a rate of 55 THB per square meter of the built-up area and are payable two years in advance. These fees cover services such as garbage collection, electricity and water supply for common areas, road and garden cleanliness and maintenance, as well as 24-hour security services.

Registration Fee: The fee for registration is shared equally (50/50) between the developer and the buyer. For leasehold properties, the fee is 1.1% of the property value, while for freehold properties, it is 6.3%.

Taxes and Other Fees: All relevant taxes, stamp duty, land and building transfer fees are payable by the buyer. These are approximately 3% of the selling price. Additionally, the cost for electric and water meter installation is 10,000 THB.

Assignment Fee: If the property is assigned to another party before registration, there is an administration fee of 100,000 THB.
